#### 4. Somerset Council CCTV

The Parish Council received a report from the Clerk on CCTV and was asked to consider the Somerset Council request to fund 5 CCTV cameras for Street at a cost of £14,174 to keep the CCTV monitoring going.

Note: Mendip cameras will feed directly into Bridgwater House and will be monitored from one central control room from 1 April 2025. Somerset Council are currently undertaking work to upgrade the system and ensure all cameras are fully operational. The clerk reported on the Somerset Council Bridgewater house control room CCTV offering including hardware/camera footage quality, current faults, draft SLA, reporting lines and meeting frequency.

The Parish Council RESOLVED to fund 4 cameras <u>once operational</u> with the first payment to be made at 3 months *subject to review of the SLA by the Policy and Finance Committee*. Clerk to check insurance arrangements.

RECOMMENDED: to review and approve the revised Service Level Agreement (SLA) for CCTV (updated 22 March 2024)
